12. Genetic Testing, except for BRCA;
13. Orthotics/Prosthetics over \$500 per item;
14. Non-emergency air Ambulance (fixed wing);

- 15. Outpatient Private Duty Nursing;
  - 16. Chiropractic Services (Outpatient) Pre-Certification required after the 24<sup>th</sup> visit.
- Primary Care Physicians (PCP) are not subjected to Pre-Certification requirements.
