# General Information

## Am I Eligible

### DOMESTIC

All Full-Time Domestic Students, including students in Study Abroad programs are automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan unless proof of comparable coverage is received by the published deadline.

### INTERNATIONAL

All International Students are automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan on a mandatory basis and cannot waive coverage.

### DEPENDENTS

Dependents are not eligible.

## How Do I Waive?

### To Waive Coverage

**Domestic students may complete the on-line waiver form by following these steps:**

3. Click on the 'Student Waive/Enroll' button. Select the 'I want to Waive' button. If you're waiving the insurance, have your current health insurance ID card ready as you will need this information in order to complete the waiver form.
