General Information

Am I Eligible

All full-time matriculated Undergraduate Trinity College students are required to maintain health insurance that is comparable in coverage and benefits to the Student Health Insurance Plan (SHIP) offered through the school. Students who meet the eligibility will be automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan unless proof of comparable coverage is received by the published deadline.
