General Information

Am I Eligible

All full-time matriculated Undergraduate Trinity College students are required to maintain health insurance that is comparable in coverage and benefits to the Student Health Insurance Plan (SHIP) offered through the school. Students who meet the eligibility will be automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan unless proof of comparable coverage is received by the published deadline.

- 4. Follow the instructions to complete the respective form. Click 'Submit' to complete the process.
 - a If enrolling, you will receive a confirmation email.
 - b. If waiving the insurance, have your current health insurance ID card ready, as you will need this information in order to complete the waiver form. You will receive an email with a reference number; please note and keep this information for your records

The deadline to waive for Annual coverage is 08/15/2025.

- Medical services rendered by a provider employed for or contracted with the Policyholder, including team Physicians or trainers, except as specifically provided in the Schedule of Benefits.
- Professional services rendered by an Immediate Family Member or anyone who lives with You.
- Charges of an institution, health service or infirmary for whose services payment is not required in the absence of insurance or services covered by Student Health Fees.
- Any expenses in excess of Usual and Customary Charges except as provided in the Certificate.
- Treatment, services, supplies or facilities in a Hospital owned or operated by a national government or any of its agencies, except when a charge is made which You are required to pay or by a Veteran's Administration.
