

General Information

Am I Eligible?

Undergraduate and Graduate Students

All Undergraduate Students of the Policyholder taking 12 or more credit hours and all Graduate Students of the Policyholder taking 9 or more credit hours are eligible for coverage under the Policy. Eligible Students are required to have health insurance coverage and will be automatically enrolled in the Student Health Insurance Plan at registration and the Premium will be added to the student's tuition fees unless proof of comparable coverage is provided by completing the waiver.

All Graduate Students of the Policyholder taking 1-9 credit hours are eligible for coverage under the Policy. Eligible Students are eligible to enroll in this Student Health Insurance Plan on a voluntary basis.

Dependents

Insured Students who are enrolled in the Student Health Plan may also enroll their eligible Dependents.

Pre-Certification Requirement:

- 16. Non-emergency Air Ambulance (fixed wing)
- 17. Acupuncture after the 12th visit.
- 18. Physical Therapy (Outpatient) Pre-Certification required after the 12th visit;
- 19. Occupational Therapy (Outpatient) Pre-Certification required after the 12th visit;
- 20. Speech Therapy (Outpatient) Pre-Certification required after the 12th visit;
- 21. Chiropractic Services (Outpatient) Pre-Certification required after the 12th visit.

- Services for which an Insured Person is not legally, or as a customary practice, required to pay in the absence of a health benefit plan.
- Personal care services and domiciliary care services.
- Services rendered by a health care practitioner who is an Insured Person's Spouse, mother, father, daughter, son, brother, or sister.
- Experimental services.

- Services incurred before the Effective Date of coverage for an Insured Person.
- Services incurred after an Insured Person's Termination Date of coverage, including any Extension of Benefits.
- Services for injuries or diseases related to an Insured Person's job to the extent the Insured Person is required to be covered by a workers' compensation law.
