Am I Eligible

DOMESTIC

All full-time Domestic Undergraduate students, Graduate students, and Second Degree Nursing students are automatically enrolled in and billed for the Student Health Insurance Plan, unless proof of comparable coverage is provided.

INTERNATIONAL
