Am I Eligible

All full-time Undergraduate, Graduate and International students are automatically enrolled in this Student Health Insurance Plan at registration, unless proof of comparable coverage is furnished.

Part-time students and students from Model Secondary School for the Deaf (MSSD) Students can elect to purchase coverage, but it is not required.

Dependents
