



# 2025-2026 Student Health Insurance Plan: Naropa University

## Who can enroll?

All full-time undergraduate students taking 12 or more credit hours and all international students will be automatically enrolled in this insurance Plan at registration, and the premium for coverage is added to their tuition billing, unless proof of comparable coverage is furnished.

Eligible students may also insure their Dependents. Eligible Dependents are the student's legal spouse (including a Civil Union partner) and dependent children under 26 years of age.

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements that the student actively attend classes. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

The eligibility date for Dependents of the Named Insured shall be determined in accordance with the following:

1. If a Named Insured has Dependents on the date he or she is eligible for insurance.
2. If a Named Insured acquires a Dependent after the Effective Date, such Dependent becomes eligible:
  - a. On the date the Named Insured acquires a legal spouse or Civil Union partner.
  - b. On the date the Named Insured acquires a dependent child who is within the limits of a dependent child set forth in the Definitions section of the Certificate.

Dependent eligibility expires concurrently with that of the Named Insured.

## Important dates or deadlines

If you are a student in the fall semester and eligible to purchase coverage and you choose not to enroll/waive before the Annual Enrollment/Waiver Deadline of \*September 13, 2025, you, and your dependents will not be eligible to enroll/waive again until the start of the next Fall semester, unless you experience a Qualifying Life Event.

\*For new students in the Spring/Summer semester, your enrollment/waiver deadline is February 3, 2026.
