Connect with a licensed doctor, dermatologist or therapist. Teladoc lets you do this by phone, web or mobile app. You can schedule an appointment for general medical care 24/7 using any of those options.

If you're looking for a mental health appointment, you can schedule one by using the web or mobile app. They're available any day of the week between 7 AM and 9 PM local time.

Coverage and costs



Benefits 101:

Copay: A flat figure you pay for a service, like \$25.

Deductible: What you pay for a service before we do.

Max benefit: The most your plan will pay out.

Negotiated charge: The max doctors can charge, based on our agreement with them.

Out-of-pocket limit: A cap on what you have to pay out of pocket.

Recognized charge: A limit on the amount your plan pays.

Provider search

If you can't get care at your student health center, reach out for a referral to visit any doctor off campus. You can find them fast on your member website or mobile app.



On break

Save the date

When to pick or waive a plan

Each year, you've got two choices:

- Enroll in the LMU Student Insurance Plan.
- Waive enrollment in the LMU Student Insurance Plan by showing you're covered under a comparable plan.

Here are the deadlines:

- Fall: August 1, 2021, to December 31, 2021 Waiver deadline: October 1, 2021
- Spring/summer: January 1, 2022, to July 31, 2022 Waiver deadline: February 4, 2022

Important note: The LMU-sponsored Aetna® insurance coverage is for one semester at a time (fall and spring). If you want to waive it, you'll have to waive it for the fall and then again for the spring.


