# **Enrolling in My SHIP**

#### Am I eligible for student health insurance?

All students registered for 1 or more credit hours (**Law School**), are eligible for the insurance. Once you meet eligibility for the first 31 days from the effective date of your Plan, you are enrolled for the remainder of the coverage period. Home-study, correspondence and online courses do not fulfill this requirement.

#### How do I review my enrollment?

Law School students with 1 or more credits are already enrolled and no action is needed. To review enrollment:

- 1. Go to <a href="https://www.gallagherstudent.com/LMU">https://www.gallagherstudent.com/LMU</a>
- 2. Follow the login Instructions.
- 3. View "Account Details" found on the lower left side of landing page.

#### How do I enroll my dependents?

This plan does not offer coverage for your dependents.

#### Am I eligible to waive?

To be eligible to waive your SHIP, you must be currently enrolled in a health insurance plan that meets your school's. waiver requirements.

#### How do I waive health insurance coverage?

- 1. Go to https://www.gallagherstudent.com/LMU
- 2. Follow the login Instructions.
- 3. Click "Waive".
- 4. You will need your health insurance information.
- 5. Follow the instructions to complete the form.

A reference number will be emailed upon submission, however final determination may take 24-48 hours.





## Will you audit or verify my waiver request?

Yes, we will verify your waiver request. The intent of the verification process is to be sure your insurance plan will cover you when you are at school. Here is how our waiver review process works:

- We check the insurance company information you entered on your form to make sure it's accurate and that your coverage is active.
- We verify most waiver requests within 1-2 business days.
- Once we verify your coverage, we'll email you at the address provided on your form to let you know if your
  waiver request was approved or denied. If we deny your request, we'll tell you why. We'll also guide you
  should you wish to revise and resubmit your form and supporting documentation.

#### Can I cancel my waiver form after I've submitted it?

Yes, but only if it's before the August 31, 2023 waiver deadline.

Follow the login instructions.

- 1. Navigate to "Account Details."
- 2. Click "Click Here to Rescind Your Waiver."
- 3. Click "Rescind My Waiver."

**Note:** Once waiver is cancelled, this action cannot be reversed. You may not edit your form after August 31, 2023.

## If I waive, but then lose my coverage, can I enroll in SHIP?

If you waive the student health insurance plan and then lose coverage, you are able to enroll in the plan that you waived. Losing coverage is categorized as a Qualifying Life Event (QLE). Other QLE's are:

- Reaching the age limit of another health insurance plan
- Loss of health insurance through marriage or divorce
- Involuntary loss of coverage from another health insurance plan

To initiate the Qualifying Life Event process:

- 1. Go to https://www.gallagherstudent.com/LMU.
- 2. Follow the Login instructions.
- 3. Click on "Enroll-Qualifying Life Event"
- 4. Complete the online form, and upload the required supporting document such as the loss of coverage letter from your prior health insurance company showing your name and the last day of coverage.

**NOTE:** Do read the form carefully as it contains very specific information on the Qualifying Life Event process.





If your enrollment in the student health insurance plan is on a voluntary basis, there is no option for the Qualifying Life Event process if you lose coverage with your current health insurance plan.

### Once enrolled, can I cancel? Get a refund?

Once you are enrolled in SHIP, you will remain enrolled for that coverage period. If you miss the annual waiver period, you may submit a request to waive or terminate spring coverage. If we approve your request, a credit for the spring semester premium will be applied to your student account or you will not be charged the spring premium. If you are an international student who is withdrawing or graduating from your school and returning to your home country, you may qualify for a refund of premium.

Note: If there are any claims submitted and paid by the carrier the plan may not be terminated.

Have changes been made to this year's plan?

No changes were made to the plan for the 2023–2024 Policy Year.

## Am I still covered if I live off campus? While traveling? When studying abroad?

Yes, your plan covers you wherever you are. As long as you are enrolled in the student health insurance plan and paid the premium, you'll be covered. Your plan also provides you with 24 hour Worldwide Travel Assistance which includes services ranging from a lost passport to helping with emergency medical assistance or arranging for emergency medical evacuation or repatriation of remains. It's important to contact **On Call International** before making arrangements on your own. Otherwise, these services will not be covered.

Other information about seeking medical care abroad:

- Always keep your student health insurance plan ID card with you.
- Save a copy of the plan brochure and/or bookmark your student health website.
- If you get sick while abroad, you will likely need to pay for your care first and then need submit bills for reimbursement. Your covered expenses will likely be considered an out-of-network expense.
- Before you submit claims for reimbursement, have the itemized bill(s) translated into English. Also include a
  letter informing the claims administrator you already paid for the healthcare service and need to be
  reimbursed.
- Write your name, ID number, address and school name are on your bill(s). This will help the claims company process your reimbursement request correctly and promptly.





#### Am I still covered after I graduate?

If you are enrolled in annual coverage and will be graduating at the end of the fall semester, you may request to cancel spring coverage. We will refund — or your student account will be credited — a pro-rated share of your premium. If you are an international student withdrawing or graduating from your school and returning to your home country, you may qualify for a refund of premium.

#### How do I enroll in Voluntary Dental or Vision Coverage?

- Voluntary Dental Insurance through Delta Dental and Voluntary Vision Insurance through VSP are standalone insurance products that are available to all LMU students if interested in electing coverage. Students needing more comprehensive coverage for dental and vision services can enroll into these programs through the Gallagher portal <a href="https://www.gallagherstudent.com/LMU">https://www.gallagherstudent.com/LMU</a>
  - If enrolling please note that you must purchase through the vendor to enroll in coverage.

# I enrolled in the voluntary dental product offered by Delta Dental. How do I obtain an ID Card?

You do not need to carry or provide a Delta Dental ID card when visiting a dentist. You can simply provide your name, student ID number and date of birth to the office staff and advise that they are a Delta Dental member.

Please login and register on the Delta Dental website to obtain a virtual ID card. The website is www.deltadentalins.com

#### How do I obtain a tax form?

If the federal government requires reporting of health insurance coverage for 2023, tax forms will be mailed to the address on file by either the Insurance Carrier or the Claims Administrator. Please refer to the Important Contact Information Section of this document for further information.
