General Information

Am I Eligible

Domestic Students

All registered full-time Domestic Undergraduate students will be automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan, unless proof of comparable coverage is provided.

Graduate Students are not eligible for coverage.

International Students

All registered International Students are required to have health insurance coverage and will be automatically enrolled in and billed on their tuition bill for the Student Health Insurance Plan, and do not have the option to waive coverage.

Dependents

Dependents are eligible.
